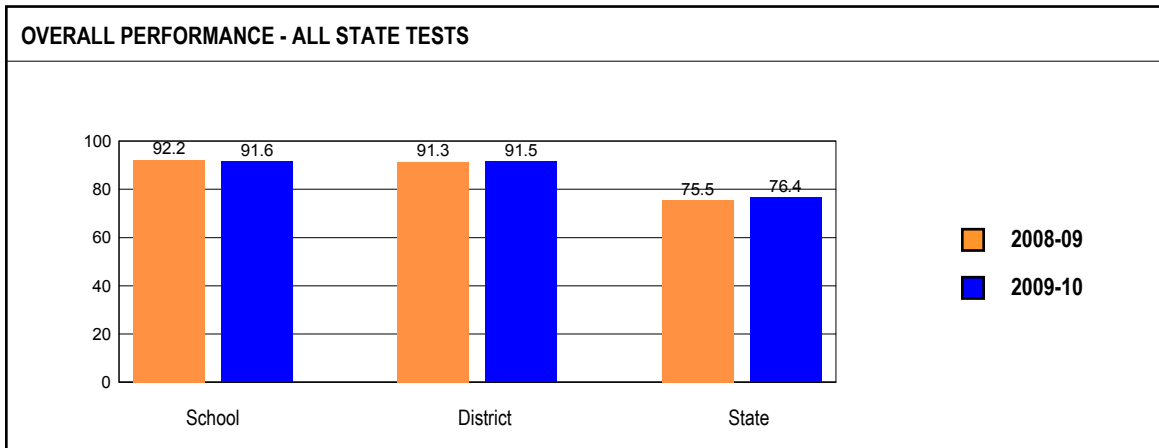

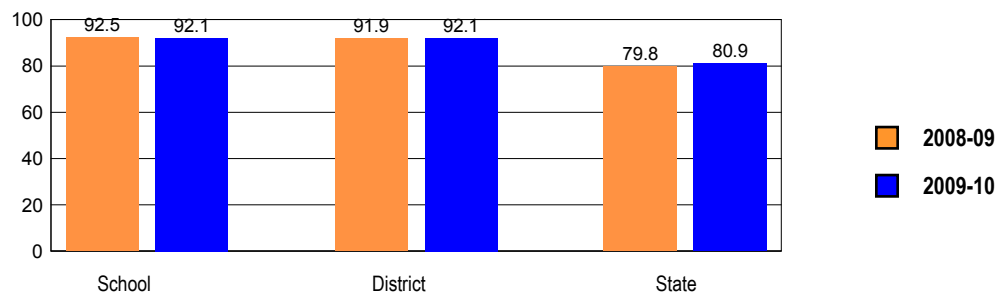

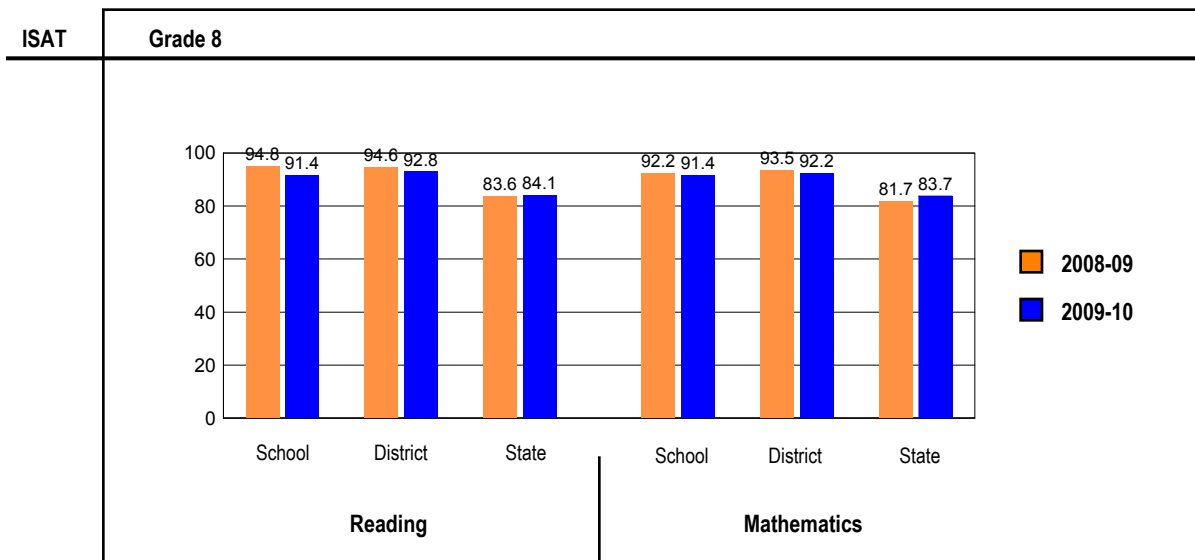
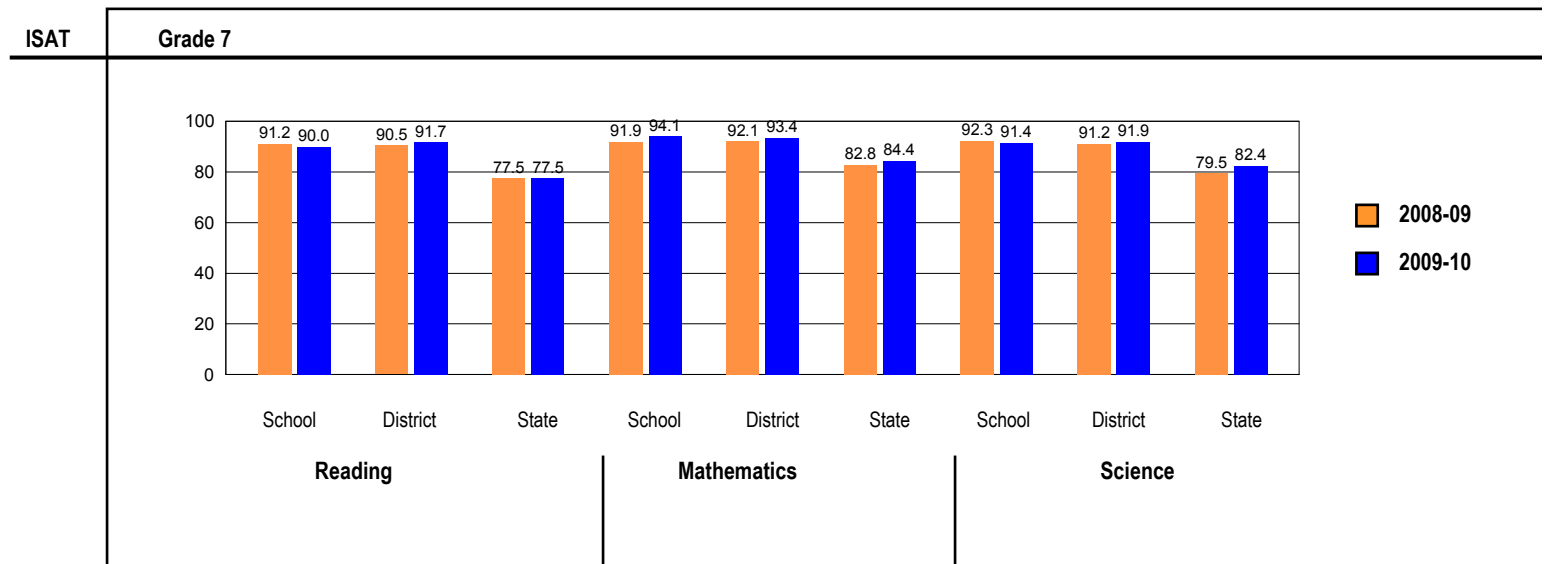
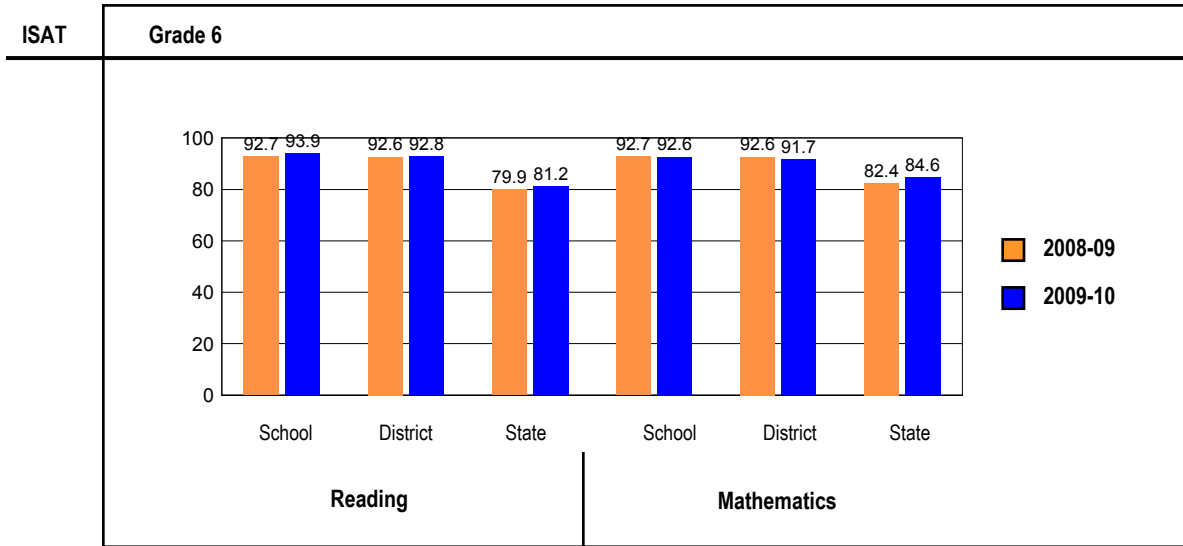


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**



**ISAT PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

**Four Conditions Are Required For Making Adequate Yearly Progress (AYP):**

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 77.5% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 77.5% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. \*\*\*
3. At least 91% attendance rate for non-high schools and at least 80% graduation rate for high schools.

\*\* Safe Harbor Targets of 77.5% or above are not printed.

\*\*\* Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

## Executive Summary

The vision of Glenview School District 34 and Attea Middle School is to enable children to be:

- Self-directed learners committed to continuous growth
- Citizens of character who value diversity
- Confident, healthy individuals who are contributing members of a democratic society

In order to maintain focus on this vision it is paramount that all students learn, grow and develop physically, mentally, socially and emotionally. With this end in mind, Attea Middle School has embarked on a School Improvement Plan, which will focus on two goals, each goal aligning with the District 34 Strategic Plan and set to run concurrently with the District 34 strategic plan.

**Student Achievement Goal:** Analyze data on student performance and grow in knowledge of applying data to better inform instructional practice within the classroom in order to increase the number of students meeting or exceeding state standards at their grade levels in the areas of Reading, Language Usage and Mathematics. In order to accomplish this goal we will need to focus specific intervention and instructional strategies on the students who currently are not meeting or exceeding the standards. We have instituted an X block intervention and enrichment period on a daily basis to help reach students at their level of instruction and provide both remediation and enrichment in core content areas. Our NWEA test data indicates tremendous success in our challenging sub group areas.

**Student Achievement Goal 1:** Increase the level of students meeting or exceeding their NWEA growth targets to 60% in Reading and Math across all three grade levels. This will be accomplished through the use of student/teacher goal setting conferences, the use of X-block time for intervention and enrichment. We will also analyze student data on Reading and Math CBM's at the 6<sup>th</sup> grade level and Reading CBM's at the 7<sup>th</sup> and 8<sup>th</sup> grade levels. We will utilize our October 2009 institute day to review actual data, identify students in need of help and be trained in goal setting conferences.

**Climate Goal 2:** Continue to increase implementation of the Response to Intervention (RTI) Problem Solving model for building, team and individual student issues and monitor the impact of program implementation on student response to interventions and increased student achievement.

The activities that students and staff will engage in during the course of the 2009-2010 will focus on reaching the goals stated in the improvement plan. Everything that we do will be based on the following guiding principals:

- All students can learn when they have appropriately defined learning goals and timely descriptive feedback by which to measure their progress
- Learning is a shared responsibility among families, students and staff
- Decisions regarding curriculum and instruction are based upon sound research and data
- Instruction will accommodate a variety of learning styles through differentiation
- Strategic direction, goals and policies are set, communicated, and monitored by building leadership which enables us to set, communicate and monitor implementation procedures
- Development and approval of the ongoing SIP will be completed in the Spring of 2010 for application in the Fall of 2010.

In addition to the above principals, all student learning will be focused on the following four questions?

What do students need to learn? (Identification of essential outcomes in core subject areas)

How will we know if students have learned? (Common formative assessments)

What will we do if they have not learned? (Remediation and research based interventions and reassessment during X block time.)

What will we do if they have learned? (Curricular enrichment through our X block time.)
